

## **Cheshire LAA 2008 – 11: Current Progress and Next Steps**

### **Background**

As partners are aware, work has been progressing well on the development of a short-term (nine month) Local Area Agreement for Cheshire and that a draft long list of Indicators, influenced and endorsed by the Communities of Cheshire Partnership and Cheshire Governance Board, was submitted to Government Office for the North West at the end of January. To date this work has been set in the context of the Government's Implementation Guidance for Local Authorities affected by LGR which stated that for split County unitaries:

- “a single LAA is negotiated with the County covering the existing geographical area for one year
- from 2009-10, each new unitary will have a separate two-year LAA”.

However, throughout this process a number of concerns have been expressed by partners about potential wasted effort, lack of capacity to engage in two separate but overlapping processes, lack of influence over corporate planning processes, difficulties associated with short-term performance management and the inability to set stretch targets (and therefore draw down reward grant) as a result of a nine-month initial agreement. In addition, national delays in the publication of key contextual documents and processes for the LAA have added to the uncertainty.

As a result and at the request of both the Communities of Cheshire Partnership and Governance Board, the County Council as the Accountable Body for the LAA have continued to lobby the Government for a different approach. Throughout these discussions it has been made clear that the one thing that is non-negotiable is that there MUST be a new style LAA in place across Cheshire by 30 June 2008. However, over the past month GONW have indicated that they would accept a more flexible approach to the overall timescale of the agreement to help the County Council and its partners manage the LGR transition period; ensuring that current work is not wasted, yet providing a firm foundation on which the new unitary authorities can build when they are ready to do so.

### **Current Position**

Following individual discussions with partners through the Cheshire Partnerships Framework, the work undertaken to date on the new-style LAA has been modified in order to develop a “severable” transitional LAA, which would include disaggregated targets where appropriate, for East and West Cheshire for at least 2008/9 and set a longer-term direction of travel for 2009-11 for the new unitaries and their partners. This will require an important balance to be struck between planning for a longer-term horizon whilst ensuring the two new local authorities and their partners are not hidebound by inappropriate targets set by their predecessors.

In practical terms this has resulted in a quick review of the long list of indicators submitted to GONW at the end of January to ensure that more relevant indicators previously omitted because they did not lend themselves to a shorter term agreement because of target setting or performance management issues are now included. This should now mean that the LAA indicator list more accurately reflects the issues and priorities for Cheshire and its communities rather than being determined or influenced by the LAA 'process'.

A revised list of LAA indicators was submitted to GONW on 12 March for onward submission to the Department of Communities and Local Government (CLG) and the 'home' departments (see Appendix A). At the time of writing, a formal response from the Government on this long list is still awaited though initial feedback from GONW has been positive.

Work is now continuing to establish / finalise baselines for each of the indicators from which both 'designated' (centrally reported) and 'non designated' (locally reported) targets for 2008/09 can be negotiated and set. As previously stated, every effort will be made to differentiate the targets on an east/west/locality basis to reflect local priorities and the need for different solutions in different parts of the county where this is relevant and practicable.

Under this revised approach as part of the sign-off process, it will be necessary to agree with the Government a "severance process" by which the two new authorities and their partners could take their elements of the LAA forward independently when they were ready to do so. This might be by a certain date, or at a time when certain conditions were in place, e.g. new LSPs, Sustainable Community Strategies and/or mechanisms for community engagement. This severance process will allow the two new unitaries and their partners an opportunity to review the priorities and targets set out in the LAA and to renegotiate them with Government for 2009 and beyond if required, once their Members, LSPs and communities had been engaged and their Sustainable Community Strategies were in place.

### **Recommendation**

**That the Governance Board notes revised approach to the development and subsequent severance of the 'new style' Cheshire Local Area Agreement and the progress made to date.**
